- New perimeter keys to Kingston need to be distributed to Pepsi, Farner, Amerigas, and Mark Fiala.
- Offering a fundraiser to Boys basketball, Girls basketball, and wrestling for them to be responsible to fill the volunteer slots in the concession stand for the Jr JHawk tournaments. Fill slots 25% of concession sales (minus fees) for the event will go directly to their program. If Opener/Closer (board approved) is provided by them, this will increase to 35% of the concession sales (minus fees).
