

# **Parking Agreement For Kennedy Students**

## **Rules & Regulations**

- Parking permits are available for purchase only by current Kennedy students.
- Parking is allowed 7:00 am – 4:00 pm on days Kennedy is in session (typically Monday through Friday), from the beginning of the school year in August to the end of the school year in June. Parking in the church lot for after-school activities is not part of this agreement.
- The Kennedy-issued permit must be hung on the rearview mirror
- Vehicle must be parked within designated spaces.
  - Oakland – yellow striped spaces on the north and east side of the building
  - Lovely Lane - yellow striped spaces along the NORTH and EAST perimeter of the parking lot
  - Good Shepherd - striped spaces on the north side of the building
- Obey directional signs and arrows.
- Speed limit in the lot is 5 mph.
- Loitering or littering in the parking lot is not allowed.
- Kennedy security personnel as well as agents of the Church will have the authority to issue tickets for parking violations. Each parking ticket/violation is \$15.00.
- This parking arrangement is considered a school-sponsored activity. Therefore the Student will comply with all Cedar Rapids Community School District rules and regulations while on school and church property.
- Students are allowed only ONE PERMIT in only ONE LOT at any given time. If a new permit is needed, the old permit must be returned before a new one is issued.
- If the permit is lost the cost of a replacement is \$15. Please see the bookkeeper.
- If the car is sold, updated information must be provided.
- Parking permits are NOT transferable to other students.
- **OVERNIGHT PARKING IN ANY LOT IS NOT PERMITTED**

## **Temporary closing of church lot**

**Occasionally there may be a large church event (such as a funeral) which would require all church parking spaces, leaving none for students. In these cases, a notice will be posted in the parking lot 24 hours prior to the event. Announcements will also be made at school. Students with church parking permits will need to make other transportation/parking arrangements on such days.**

## **Revoking parking privileges**

The Church and School reserve the right to terminate a parking agreement with 5 days written notice. Notice describing the violation(s) of the agreement will be sent to the Student at the address listed on the application by certified mail, return receipt requested. No refund of parking fees will be given.

## **Towing**

The Student authorizes the Church and School to tow the vehicle if it is parked in an area or on a date or during hours not permitted by this agreement.

## **Indemnity and release**

The Student (or Parent/Guardian in the case the Student is a minor) indemnifies and releases the Church and School from any and all claims, actions, suits or demands for damages of loss to the vehicle, its accessories or contents, while on the Church or School property, including investigation and reasonable attorney fees. The Church and School recommends that the owner of the vehicle obtain insurance to cover any loss or damage to the vehicle, its accessories and contents.
